ABSTRACT

The Canal: Photographs of Robert Cotton records hold material created and collected by The Phillips Collection Curatorial Department during the process of organizing the 1986 exhibition. Included are correspondence, installation material, and an exhibition announcement.

SCOPE AND CONTENT OF THE COLLECTION

The Canal: Photographs by Robert Cotton, held at The Phillips Collection in 1986, was an exhibition which included 40 black and white photographs of the Chesapeake and Ohio Canal by the former ambassador of Australia to the United States, Robert Cotton.

These curatorial records were collected and created during the research, planning and execution of *The Canal: Photographs of Robert Cotton* exhibition.

The exhibition opened at the Phillips Collection in Washington D.C. on March 15, 1986 and closed May 11, 1986.

The primary creator of the exhibition planning records was The Phillips Collection Curatorial Department.

The bulk of the collection consists of exhibition related documents. The records include correspondence, guest lists and installation material.
